



WAIVER OF LIABILITY & IMAGE RELEASE

I HEREBY ASSUME THE RISKS OF PARTICIPATING AT TRAILMASTER AND ALL OF ITS ASSOCIATED EVENTS AND RACES, INCLUDING THE 5 KM RACE, 10 KM RACE, AND 21 KM RACE DISTANCES.

In consideration for allowing me to participate at TRAILMASTER and any other event organised by The TriFactory LLC I hereby ascertain that I am taking the following action for myself, to be accepted by my executors, administrators, heirs, next of kin, successors, and assignees, or anyone else who might claim or sue on my behalf, and I expressly acknowledge that it is my intent to take these actions. I certify that I am physically fit and have sufficiently trained for participation in this event(s), and have not been advised against participation by a qualified health professional.

- a) **I AGREE** to abide by all the Rules & Regulations as provided and as will be provided to me by The TriFactory LLC. I accept that failure to adhere to these Rules & Regulations, in addition to or alongside failure to conduct myself in an appropriate manner as deemed by the Head Official and The TriFactory LLC management will result in my disqualification. **I ALSO AGREE** that prior to participating at TRAILMASTER and its associated races I will familiarise myself with the Race Course, ensure that all my equipment is safe and ready for use, and ensure that I am ready and capable of participation therein.
- b) **I WAIVE, RELEASE, AND DISCHARGE** from any and all claims, losses, or liabilities for death, personal injury, partial or permanent disability, property damage, medical or hospital bills, theft, or damage of any kind, including economic losses, which may in the future arise out of or related to my participation in TRAILMASTER. The following persons or entities: The TriFactory LLC and its partners, managements, and employees, Wadi Degla Protectorate, Event Producers, Event Sponsors, Event Organisers, Event Volunteers, and any and all public and private entities related to Trailmaster, including officers, directors, employers or employees, representatives or agents thereof, or person or event otherwise associated with the event, even if such claims, losses, or liabilities are caused by the negligent acts or omissions of the persons or entities I am hereby releasing or are caused by the negligent acts or omissions of any other person or entity.
- c) **I ACKNOWLEDGE** that there may be persons, animals, or vehicles on the course, and I ASSUME the risk of running or otherwise participating at TRAILMASTER and its associated races. **I ALSO ASSUME ANY AND ALL OTHER RISKS** associated with participation at TRAILMASTER including, but not limited to falls, contact and/or effects with other participants, effects of weather including heat or humidity, defective equipment, the condition of the roads, and any hazard that may be posed by spectators or volunteers. All such risks being known and appreciated by me, I further acknowledge that these risks include risks that may be the result of the negligence of the persons or entities mentioned above in paragraph (c) or of other persons or entities. **I ALSO ACKNOWLEDGE** that The TriFactory LLC has the right to remove me from my race if a member of its management, the Head Official, a lifeguard, or any safety personnel deem that I am unwell or unfit to continue participation in said race. I understand that this will not entitle me to any refund of my registration fees and that I will not be entitled to challenge this decision.
- d) **I GRANT PERMISSION** for the use of my name and/or likeness in all images or videos relating to my participation and presence at TRAILMASTER and I WAIVE all rights to any future compensation to which I may otherwise be entitled as a result of the use of my name or likeness in such media.
